5. Implementation Wilhelmshaven Declaration

5.1 Protect and strengthen the Outstanding Universal Value (paras 1-16)

Members and Advisors will be informed on the processes resulting from the decisions of the 45th and 46th session of UNESCO World Heritage Committee in 2023 and 2024. The Task Group World Heritage informs on the status of the development of the joint Strategic Environmental Assessment (SEA) and the timeline for planning and implementation. Participants are invited to adopt the timeline and the way forward **(WSB 45/5.1)**.

5.2 Enhance Sustainability of Human Uses and foster Transformative Change (paras 17-37)

Task Group Coordination and Management

The regions will inform on the national implementation steps of the EU Nature Restoration Regulation (NRR), also with a trilateral perspective with input from the relevant trilateral groups, also referenced in the TG-CM Progress Report **(WSB 45/5.2)**.

Members and Advisors are invited to 1) consider the corresponding proposal on NRR; 2) agree to pause TG-CM activities reviewing the Framework and activity 6 of the SIMP Key Topic Fisheries and 3) discuss the further focus of the LANICE project regarding energy transition.

5.3 Mitigate and adapt to climate change (paras 38-43)

Climate Change Adaptation Strategy

The trilateral Climate Change Adaptation Strategy (2014) was revised by the trilateral Expert Group Climate Change Adaptation. Members and Advisors are invited to adopt the revised strategy (**WSB 45/5.3**) and consider it as an annex of the Esbjerg Declaration.

5.4 Manage and communicate effectively (paras 44-56)

Wadden Sea Quality Status Report and Trilateral Monitoring and Assessment Programme

CWSS performed an internal review of the QSR planning and production process and is developing a corresponding QSR guidance document including a process description. This guidance document should be the basis for an efficient future QSR process. Its status will be presented during the meeting together with information on the technical status of the trilateral data handling and state-of-affairs regarding the Trilateral Monitoring and Assessment Programme (TMAP). Members and Advisors are invited to advise on the process.

5.5 Intensify collaboration and strengthen engagement by working with partners (paras 57-66)

Stakeholder involvement

During WSB 42, and as a consequence of the cancellation of the Wadden Sea Forum, CWSS was requested, together with interested persons, to develop a proposal on how to involve stakeholders in the future including taking into account the potential role and capacity of the Partnership Hub. Members and Advisors are invited to discuss the outlined way forward and to agree on the proposals within the document (**WSB 45/5.5**).

6. Trilateral Governance

Trilateral Governmental Conference

Members and Advisors are invited to note, and discuss where necessary, the information on planning of the Trilateral Governmental Conference in Denmark in 2026 and status of activities for drafting the next Ministerial Declaration (**WSB 45/6/1 -see annex-**).

TWSC business plan

CWSS will provide an updated TWSC business plan for 2025 (**WSB 45/6/2 - see annex-**). Members and Advisors are invited to note the updated plan.
